SECTION 4: Fitst aid measures

4.1 Description of necessary first-aid measures

General advice	Do not get in eyes, on skin or on clothing. Do not breathe dust or mists. Wear chemical splash goggles or face shield, protective rubber gloves, a long-sleeved shirt and, if necessary, a rubber apron when using this product.
